Nordimet[®] is colour-coded according to the dose that has been prescribed. Your treatment may look different to the picture.

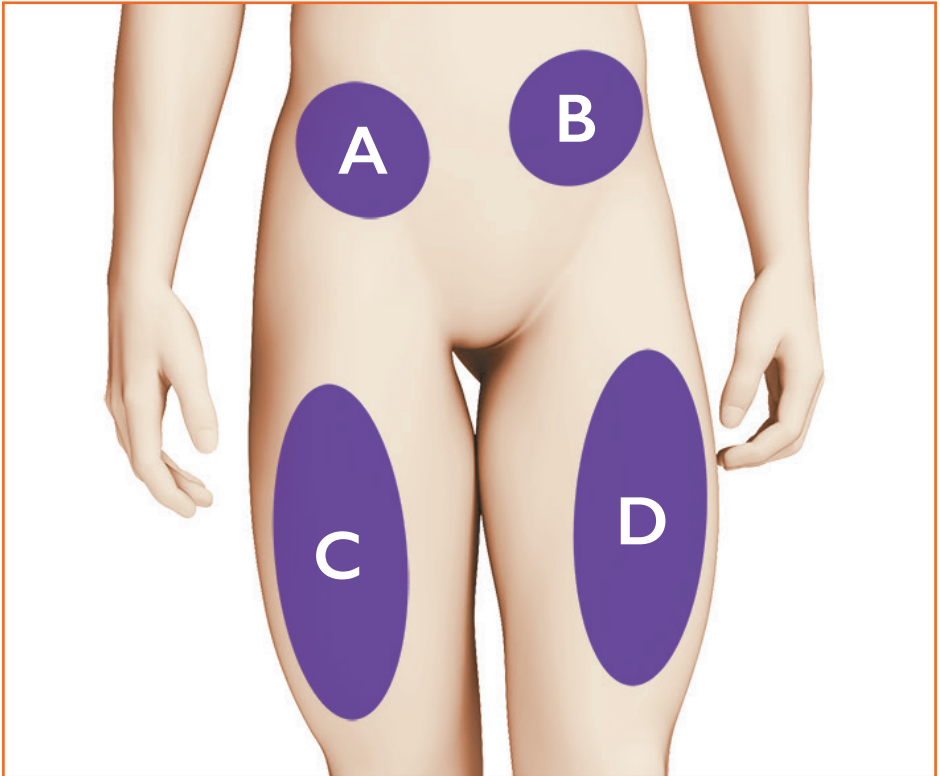


YOUR INJECTION CALENDAR

Agree which day of the week would be most convenient for you to give your child their injection. Keep a track of their injection site each week so it can be rotated.

Check your child's last injection site and if there is any change in skin colour such as redness or swelling, oozing or pain consult your doctor or nurse as your child may have signs of an infection.
